About the Project



Temporomandibular Joint (TMJ) ankylosis is a debilitating condition characterized by severely restricted mouth opening, facial deformity, and significant psychological distress for patients. A major cause is untreated or undiagnosed TMJ fractures, which can progress to intra-articular damage, leading to fibrosis or bony fusion. In India, the lack of awareness and specialized intervention for TMJ fractures often results in delayed diagnosis and limited access to appropriate surgical expertise. Consequently, patients frequently present with advanced ankylosis, requiring complex surgical correction.

TMJ arthroscopy is emerging as a minimally invasive diagnostic and therapeutic tool for preventing TMJ ankylosis. It enables direct visualization of joint structures, offering enhanced diagnostic accuracy with low morbidity.


This project aims to provide comprehensive support for the prevention, early detection, and management of TMJ ankylosis, particularly among children and young adults from economically weaker sections. The initiative focuses on awareness generation, screening camps, surgical interventions, post-operative rehabilitation, and capacity building of healthcare professionals.

GCSRA has empanelled the Department of Maxillofacial Surgery, Government Dental College and Hospital, Ahmedabad, to implement the project. Initial activities, including identification of beneficiaries and procurement of equipment, have been initiated. **During the reporting period, a pilot activity was undertaken, and one beneficiary was successfully operated upon.**
